The work in general includes, but is not limited to, demolition and removal of casework, walls, flooring and exhaust fans all as part of the remodeling of select areas of each building including classrooms, storage rooms, stairwells and fitness areas. All work includes installation of new partition walls, casework, flooring all associated mechanical, electrical, and plumbing work. Work is to be awarded as a single contract.
