

AREA II north hallway by center hall junction and restrooms (with lockable door), door to boiler room, and north hallway at main lobby access by room 19; 3 total.
- 3. Contractor to place worker and equipment decontamination units in the following locations: AREA I in west hallway, connected to doorway of room 51. If Alternate is added, in hallway connected to the hallway tunnel connecting rooms 51 & 25. - 5. Dumpster to be placed in the northeast parking lot of the building. Flooring in the east portion of the north hallway to be properly protected from transport of waste.
